- 1) Josh – Technical Officer: If a station submits a 10 hour live stream, how will judges be directed to the relevant parts?

Proposer's Response: Submitting text alongside the livestream, pointing out the relevant parts, would solve this issue.

- 2) Avneet – Chair: How will the host station download such massive files?

Proposer's Response: Submission of YouTube links would solve this issue.

Avneet's Response: Not all stations use YouTube, this excludes some stations who use other methods to distribute their material.

- 3) Katherine – YSTV: How will stations with larger live projects such as roses, general elections or unibrass be expected to pick one uninterrupted livestream to out forward for consideration considering that one specification stream doesn't show the entire scope of the production?

Brief Outline: To reduce the number of NaSTA Award categories to 20 defined in Appendix 1: Proposed list of NaSTA Awards

Questions presented:

- 1) **Haaris – NUTV: Why did you not submit tis as a motion that could be taken in parts?**

Proposer's Response: We have constitutionally reached out limit on awards, it takes lots of time, and a reduction has been discussed from the AGM. The award list should be taken as one part.

- 2) **Liz – CUTV: For the videos that would've been submitted into the Music category is that content not good enough to submit for an award? Where should it be submitted instead?**

Motion 2a: To Amend the NaSTA's Awards Categories

Brief outline:

To replace the Best On-screen Male and Best On-Screen Female awards with the following two award categories:

- 1). **Best Dramatic Performance** - Entry format: 5-minute video A showreel demonstrating the on-screen acting skills, styles and techniques of a particular Individual in any form of fictional production. This showreel may be made up of content from multiple productions or episodes.

- 2). **Best On-Screen Talent** - Entry format: 5 minute video A showreel demonstrating the on-screen skills, styles and techniques of a particular individual in any production excluding fictional content. This showreel may be made up of content from multiple productions.

Questions presented:

- 1) Siri - LA1TV: if the award for changing the categories to presenter and actor goes through, when the Oscars have their best director, it is non gendered...88 years, but only one woman has won the award. If this motion does pass, can we insure that the judging is fair?

Proposer's response: Proposer acknowledged that this is a valid question, and said he was not sure

- 2) Kat - GUST: I spoke to incoming controller, I agree and think it will be harder for women to put themselves forward.

Proposer's response: Proposer acknowledged that this is a valid point. He raised the point that many stations have submitted many women for Best Female, and that should not be ignored

- 3) Liz - CUTV: Could someone enter into only one or both of the award categories?

Proposer's Response: As long as the same content is not submitted into both categories, as this is against the rules.
